**Application fee: included with recording**

**Dixiana Store**

As an artist, you are singing songs written by someone else. Publishers and songwriters do request a small usage fee when your recording is for promotional purposes only. If you want to sell any of your recordings, you will need a mechanical license. This would allow your songs to be included in the Dixiana store.

Please circle whether you need a mechanical license to sell your recording or a usage fee limited to promoting the song only.

Accepted songs will be reviewed periodically for continued inclusion in the store.

**Payment**

You are also accepting the payment schedule of 50% commission to you, the artist and 50% retained by Dixiana Music after 10% has been deducted for administrative costs and taxes. Where applicable, taxes will be paid by Dixiana Music.

You maintain the rights to have our store books audited.

Dixiana Music shall not be required to pay commission on professional or complimentary copies or any copies or derivative works, which are distributed or sold at or below Publisher’s cost or for promotional or similar purposes. .... I choose to opt-out of complimentary copy distribution.

You are accepting the responsibility of keeping us informed of address changes, email changes and any change to your email address on your PayPal account. Sales are tallied during the first week of the month for the previous month. A minimum of \$5 commission will generate a payment by the end of that month. You will receive a statement by post with your accompanying check or by email if you choose to receive your payment through PayPal.

**Legalese:**

When appropriate in context, all references herein to the singular shall include the plural and to the masculine gender shall include the feminine.

This Agreement sets forth the entire agreement of the two parties and shall be construed in accordance with the laws of the State of Tennessee with respect to contracts executed and to be performed therein and shall be binding upon parties their respective successors, heirs and assigns in the event of litigation. In the event that any provision of this Agreement shall, for any reason, be held invalid or unenforceable, all other provisions herein shall continue in full force and effect. This agreement may not be modified or amended except by written agreement signed by both parties.

All notices given hereunder by either party to the other (excluding accounting statements) shall be transmitted in writing by US Registered or Certified Mail, Return Receipt Requested to the parties' addresses set forth in this document.

Publisher shall have the right to collect (or authorize others to collect) on behalf of the Composer, the "writer's share" of all Monies payable with regard to the composition pursuant to the Audio Home Recording Act, 17 United States Code Section 1002, et seq. ("AHRA Monies") and Composer hereby assigns said AHRA Monies to Publisher. Writer's share of AHRA Monies shall be distributed by Publishers to Composer in accordance with the terms of this agreement.
